The 5th IWF will gather the representatives of Belarusian governmental bodies and agencies, national and international governmental and non-governmental organizations, foundations, scientific and educational institutions, business community, mass media, both national and foreign.

MAIN OBJECTIVE OF 5th IWF

The 5th IWF aims at working out optimal solutions regarding enhancing of water resources use efficiency for the needs of national economies and protection of water resources from exhaustion in changing climate conditions.

Key topics of the 5th IWF:

- Sustainable use of water resources in changing climate conditions;
- Modern approaches towards protection of water resources from contamination and exhaustion, water treatment technologies;
- Trans-border cooperation in the sphere of protection and use of trans-border water objects;
- Hydropower engineering, use of geothermal water resources, utilization of recreational potential of water objects in Belarus.

Within the 5th IWF it is scheduled to carry out 2 international seminars (round tables) under the auspices of Central European Initiative (CEI): seminar “Evaluation of impact of building of hydro power stations in Central and Eastern Europe countries on ecological status of small and medium rivers” and seminar “Strategic middle-term planning of water resources and water-management systems: OECD recommendations, approaches, planning tools” (within the project “EU plus water initiative for Eastern Partnership countries”).

Form of participation:

- Plenary report (up to 30 minutes)
- Report at topical section (up to 15 minutes)
- Poster report/presentation
- Remote participation.

Terms of participation in 5th IWF

To take part in the 5th IWF you should:

1. **Fill in by September 11, 2017** the electronic registration form, place at the Forum's web-site:

2. **Attach to this form** the electronic version of your report/presentation (file's name – author's surname with hyphenated number of section. E.g. IvanovAN-3).

Registration form and report/presentation can be sent to Forum's organizing committee office either via e-mail, or by usual mail.

After receiving and reviewing of submitted materials the Organizing Committee will form the Working Programme and will **no later than September 17, 2017** inform those, who have submitted their registration forms

and materials, about their supposed forms of participation in the 5th IWF, terms of payment of registration fee and, in case of receiving of confirmation of participation, will forward to their addresses invitation letters and Preliminary Programme of the Forum.

The authors will bear responsibility for scientific content and delivery form of their materials. Materials which do not meet Forum's topics, which have been not drafted according to requirements, and which have been submitted after deadline date will be not reviewed and will be not sent back. The Organizing Committee will keep the right to select finally reports for plenary and topical sections. The Programme of the 5th IWF will be uploaded at the Forum's web-site **by October 1, 2017.**

PUBLICATION

To sum up the results of the Forum there will be published "Collected Reports of the 5th IWF" containing papers/reports in Russian and/or English languages in author's edition, selected by the Organizing Committee for plenary and topical presentations.

Requirements for submitted reports/presentations

Volume – up to 6 pages, including literature/references list. Materials submitted in electronic form are to be prepared in Microsoft Word format ("Times New Roman" font): report's title – 12, semi-bold, caps lock; authors' names – 12, normal font; organization's name – 11, normal font; main text – 12, normal font; paragraph – 10.0 mm; interline spacing – ordinary; all margins – 2.0 cm; tables can be placed in the form convenient for the author; number of sources references – no more than 5; pages are not to be paginated; all figures and diagrams are to be submitted in editable form. Text of report will be not subject to editing and is considered as original version for further duplication.

REGISTRATION FEE

Payment requisites (in BYN, RUB, EUR, USD) will be given to participants **no later than September 10, 2017.** Registration fee can be also paid on October 4 - 5, 2017 in course of registration procedures.
